WHAT'S NEW

Antech[®]

Avimark now integrates with Antech Diagnostics. Create requisitions for Antech Reference Labs or Antech In Clinic Labs from the Patient Area or Medical History.

If your practice is currently using Antech, the credentials for your practice will migrate to the new Advanced Options.

Below are some of the features and enhancements that come with the Antech integration. Detailed instructions for setup and workflow are contained within the Antech user guide.

- Antech released a new bi-directional integration available to all users where the order is immediately placed and visible to Antech labs. They have also provided an embedded portal for ordering and viewing lab results referred to as Antech HealthTracks.

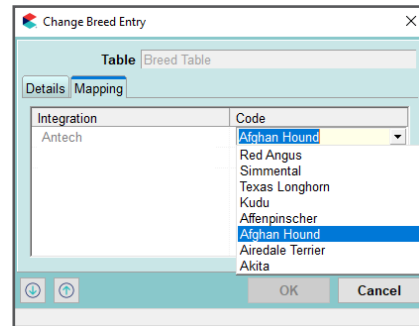
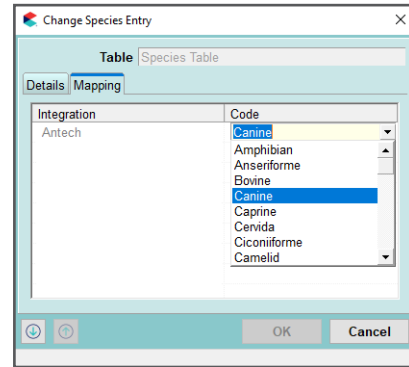

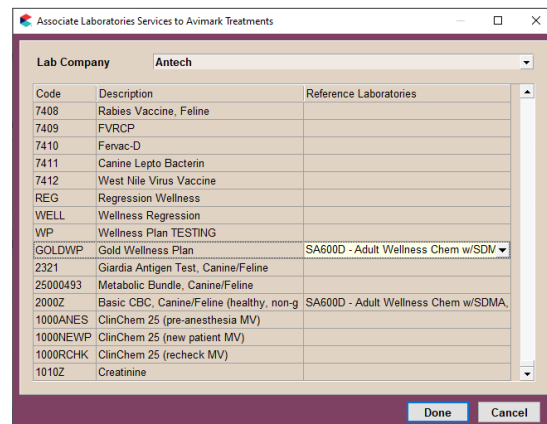
- Species and Breeds System Tables has a new tab for mapping Antech to Avimark.

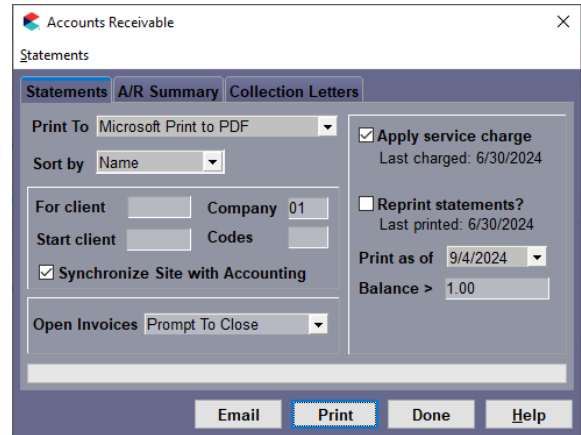

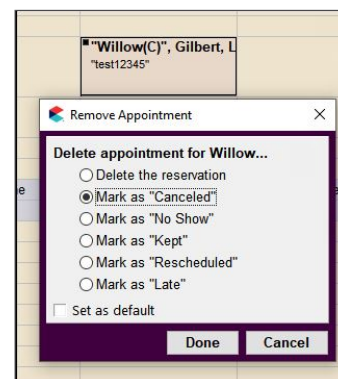
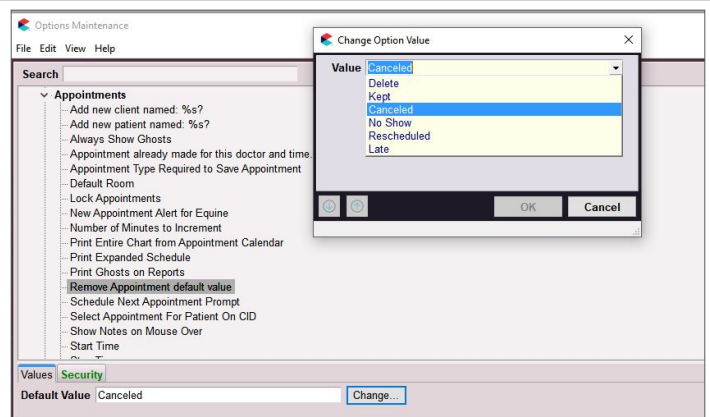
Accounts Receivable

Corrected the Statement Site Synchronization option. Site clinics can now synchronize the last accounting transaction and update the clients Statement site. This allows the clinic to print the correct site information on the Statement without changing the Clients company number. Statements will still need to be run based off company number, but the correct site name/address will print on the Statement.



Appointment Calendar

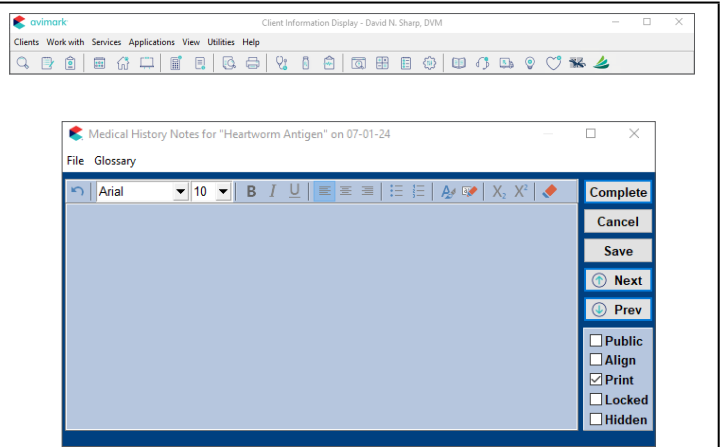
Users can set a default status for removing appointments under Advanced Options or when removing an appointment on the Appointment Calendar.



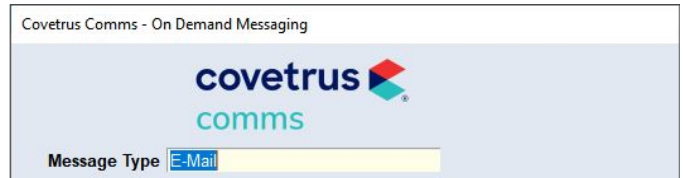
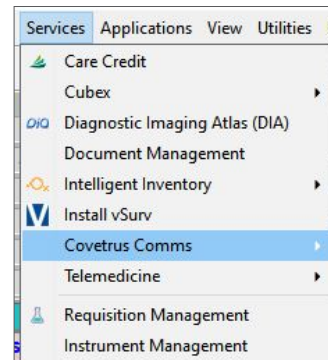

The Lab Type “(all)” was added to the Download Requisition window to download from all integrated labs at one time.

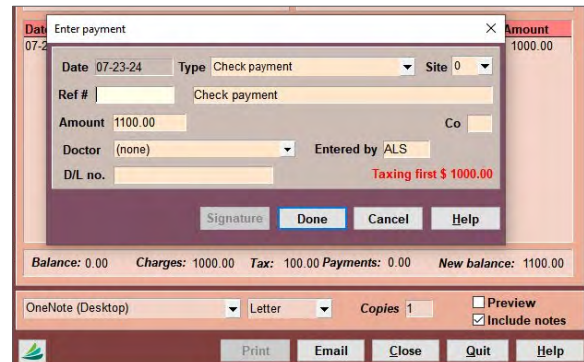
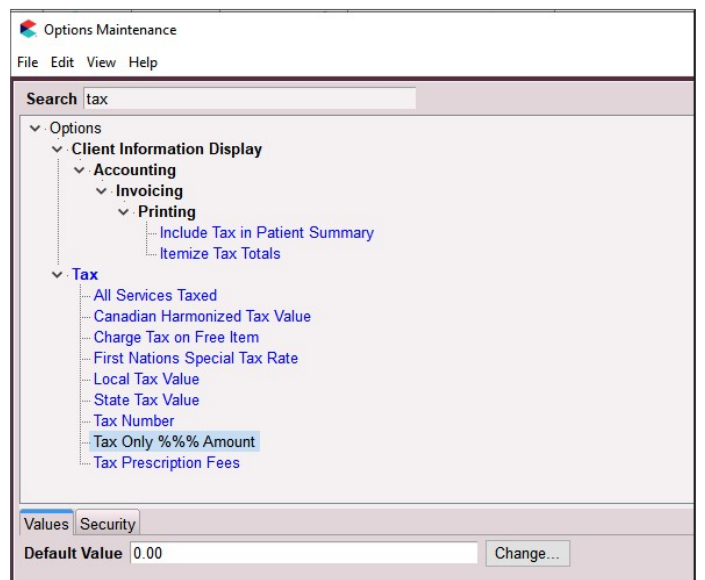

Tax Restrictions

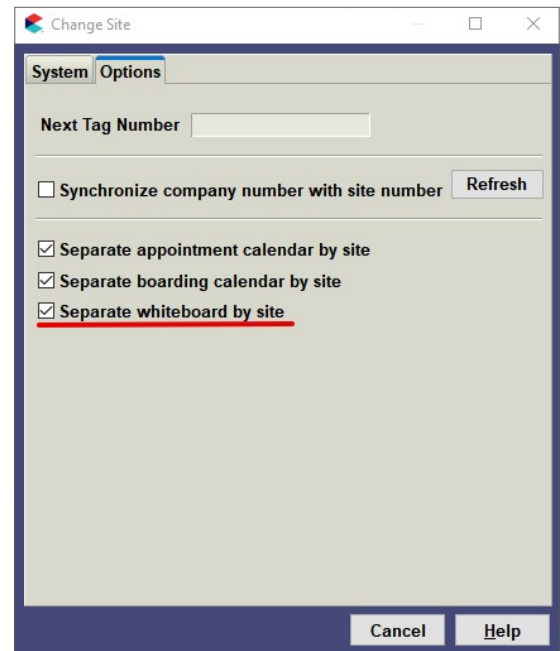
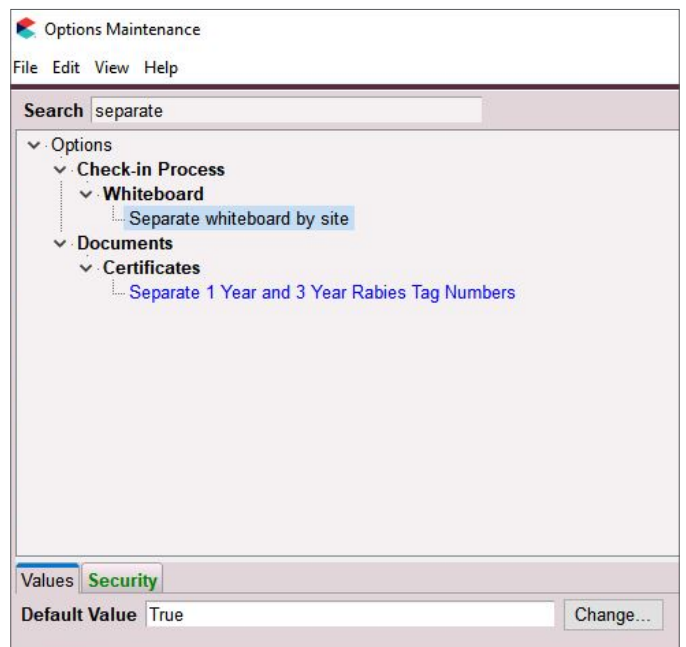
Practices that have restrictions on how much they can tax can be set within Advanced Options. It will also show on the payment window. If there are no restrictions, the entire amount will be taxed.

Whiteboard

Created an option to separate the Whiteboard by site. The option is set to True by default but can be changed within Advanced Options.
